## Student Visa - List of required documents

**Context** : Application for a long-term D visa for students (including PhD) *enrolled* at a Belgian public institution of higher education for graduate studies or a full-time preparatory year OR for students *admitted* to study OR for students enrolled in an *entrance examination/test*. This visa does not concern exchange students (Erasmus), students doing an internship in Belgium or students of private institutions of higher education.

If you are a Third Country National wishing to stay in Belgium for more than 90 days, you need to apply for a D type visa.

These are merely the standard documents. We might require further evidence at the course of the process. **It is mandatory to send them as separate pdf documents. Any other form (photograph etc) will be rejected.**

- Enclosed visa application form
- 2 recent identity photos in color, standard size 35 x 45 mm with light and uniform background. Please note your name on the back side of the photos
- Enclosed language form
- Enclosed notice "willingness to integrate"
- National passport valid at least 12 months & containing at least two empty visa pages – please prepare copies of the identity page + issued visas
- Copy of your valid residence permit in FIN/SWE/NOR/ISL/DNK/EST
- Enclosed less than 6 months old medical certificate that has to be filled out by a doctor
  - Issuing doctor  
FIN/SWE/NOR/ISL/EST: any doctor of your choice  
DNK: the advised doctor on the back side of your yellow health insurance card (please provide a copy of this card)
  - Apostil legalization by a notary public required in all other countries than DNK and EST that have a bilateral agreement with Belgium

From the age of 18 and older: police clearance certificate from your current country of residence FIN/SWE/NOR/ISL/DNK/EST. Requirements: recent max 6 months, issued directly in English/Dutch/French/German or provided with a translation by a sworn translator into one of these languages. Apostil legalization by a notary public required for extracts and translations from NOR and ISL

Certificate by an institution of higher education proving that you are enrolled in higher education or a full-time preparatory year, OR that you are admitted to study, OR that you are enrolled in an entrance examination or an entrance test

- Students that are enrolled in higher education or a full-time preparatory year may receive a visa valid for 12 months
- Students that are admitted to study or are enrolled in an entrance examination/entrance test may receive a visa valid for 4 months

Copy of a diploma or a certificate of studies that gives access to Belgian higher education (secondary school diploma or baccalaureate). If the diploma is not yet published at the time of the visa application, you have to present a certificate of non-publication issued by the competent academic authority, or a certificate of achievement issued by the institution attended

Curriculum vitae

If under the age of 18, proof of parental or guardian consent

Proof that you have or will have health insurance covering all risks in Belgium for the duration of your stay. If you are not affiliated to a Belgian mutual association (*mutuelle/ziekenfonds*) or if you cannot provide proof that you will be affiliated upon arrival in Belgium, you can also provide us with proof of private travel health insurance. This insurance must be valid for Belgium, for a minimum of 3 months, and have a coverage of at least 30.000 EUR. The compensation due by the insurance company must be recoverable in Belgium

- ⇒ Failure to provide proof of health insurance does not affect the admissibility of the visa application. However, it does have an impact on the duration of the validity of the visa since the applicant who does not present a health insurance will receive a visa valid for 4 months, even if the student is enrolled in Belgian higher education. Following your arrival in Belgium, you will receive a registration certificate valid for 4 months from the municipal administration and will have to present a health insurance at the latest 15 days before the expiration of this certificate. If the health insurance is not presented in time, the Immigration Office will give you the order to leave the territory

Please note that the embassy may also accept a certificate of scholarship in which the scholarship-granting organization formally commits itself to cover your medical expenses during the period in which the scholarship is granted

Student questionnaire, which the embassy will provide to those students that should fill it in.

Proof of sufficient income of min 803 EUR net/month during your stay in Belgium. Please consider that bank statements are not considered as a valid proof of solvency. Accepted documents are one of following or their combination:

- Certificate stating that you are or will soon be receiving a scholarship or loan
- Commitment that charge will be taken (annex 32). For further instructions your guarantor should contact the Belgian embassy accredited for the country where he/she is residing
- Financial agreement with the Belgian university/organization attesting that you have blocked the needed amount (803 EUR multiplied by the number of months of your stay in Belgium for the first academic year) on their account and will receive it back in monthly transfers during your stay in Belgium

Citizens of Morocco, Israel, San Marino, Japan and Turkey are exempted from the visa handling fee

We advise you to read the information through carefully and check that you do not fall into any of the few categories of exemption (younger than 18, or Turkish citizens studying in private education who are exempted from the contribution fee, long term residents with special status in another EU country who pay 184 EUR, etc.)

**Note: If you receive a scholarship**

- from a public organization established in Belgium (state, communities, regions, provinces, municipalities, public universities, public utility foundations)
- from an international organization of which Belgium is a member (such as the EU funded Erasmus scholarships)

you are exempted from both the handling fee and the contribution fee

- If you have been granted a scholarship by a Belgian organization, please present a standard form (link to the form in French [here](#) and in Dutch [here](#)) filled out by a representative of the organization. You can find the form in English on the website.
- If you have been granted an Erasmus scholarship by an organization in FIN/SWE/NOR/ISL/DNK/EST, please have the document "Bourse attestation" filled out by a representative of your organization. If it concerns an Erasmus scholarship, the university representative needs to check the second lowest box "an international organization established under public law and of which Belgium is a member" (this refers to the EU)

The application is only considered admissible with a proof of the paid fees.
